# **European Limited Warranty for**

## 4EVERblue and 4EVERdark

Liquisol bvba warrants to the first customer of the 4EVERblue and/or 4EVERdark ("the Product") identified in the fully completed and signed Record of Installation that if the Product has been correctly applied on a surface with a minimum slope of 15% by an Authorised Liquisol Applicator but peels, cracks, crazes or fails to adhere by reason of defective Product during the applicable warranty period of 5 years, it will supply new product free of charge. Additionally, the colour stability of the product are covered by this warranty.

#### This Warranty is only valid where:

- The Product has been applied by an Authorised Liquisol Applicator; and
- The Product has been applied in accordance with the instructions as outlined in the 2017 Liquisol application Manual; and
- The customer notifies the authorised Liquisol Applicator in writing within one month of the defect appearing; if it is not practical for the customer to notify the Authorised Liquisol Applicator, written notice should be given to Liquisol byba directly; and
- Within 30 days after the application, the Paints and varnishes Cross-cut test has been performed with an Elcometer 1540 and the result is classification 1-3.

Installation (in the form attached) was fully completed and signed on or around the time of completion of the installation and sent to Liquisol bvba. Any notice of defect must be mentioned.

### This Warranty is not valid where:

- The coating was not installed by an authorised Liquisol Applicator; or
- The Record of Installation was not fully completed and signed on or around the time of completion of the installation and sent to Liquisol byba; or
- The product is removed by the customer before Liquisol byba and the Authorised Liquisol Applicator have inspected a reported defect; or
- The failure is due to a surface or a framing system failure; or
- The product has been modified or repaired by a person not authorised by Liquisol byba; or
- The product has been subjected to abnormal use, misuse or neglect; or
- The product has not been installed in line with the installation guidelines recommended in the 2017 Liquisol Application Manual; or
- The product defect is due to a lack of, or improper maintenance and cleaning not in conjunction with Liquisol's recommendations; or
- The product is over 2 years old since the date of purchase before it was installed; or
- Prior to the installation, the product was not stored in its original packaging nor under the environmental conditions as recommended by Liquisol bvba.
- Within 30 days after the application, the Paints and varnishes Cross-cut test has been performed with an Elcometer 1540 and the result is classification 1-3. Or no test has been performed.

Where Liquisol 4EVERblue and 4EVERdark is applied by a non-Authorised Liquisol Applicator, Liquisol byba's warranty applies for a maximum of 1 year across the product.

In the event of a successful claim resulting in new coating being applied, the warranty period for the replacement coating will only be if the remaining period from the previous application.

This Warranty is given in place of and excludes all other warranties and conditions, whether express or implied by statute or common law. Nothing in this Warranty shall be deemed to exclude or restrict Liquisol bvba's liability for death or personal injury resulting from Liquisol bvba's negligence. Liquisol bvba shall not be liable for any consequential or indirect loss or damage whatsoever whether arising from the supply of the Product, its use, from any defect or failure in its performance or in any other way. Liquisol bvba's liability under this Warranty shall never exceed the cost of replacing the Product.

This Warranty may only be assigned by the customer during the Warranty Period and only then with Liquisol byba's and the Authorised Liquisol Applicator's prior written consent.

Image of the cross hatch test result:


